In reality, the life of transgender is way too much difficult than others as they are not much socialized. They face physical violence from society, not getting jobs,

Earlier only two genders were there i.e. male and female but now there is a third gender too, "The Transgender" and it is also a part of society. Only acceptance from people and from society will make a change for them. Proper education is necessary to be given to people only than acceptance of transgender in society will be to its fullest and will be accepted as normal human beings. They too have the equal place in society like males and females.

Society doesn't count the deformity of a person to a part of it. Transgender are one of those persons who come on top of this. They are rejected, abused sexually and physically, beaten up by the authorities and face many problems. Many rights are made for the betterment of transgender people and to protect them from such physical and mental torture. Transgender are being pushed into prostitution. To abolish or to stop all wrong activities, our constitution has made articles for transgender people. Earlier, the transgender were given a specific place in our society. They used to give blessing for peoples family, children, business etc. and there situation was quite well. But now, in today's scenario they are not considered a part of our society and are treated very badly. They are life just only for the sake of blessing and for own selfish work. But in reality, these people are far better than other society people in terms of behavior, conversation, etiquettes, etc. being a separate community doesn't mean they are not a part of society. They have their equal opportunities just like other male and female community. Even the Article under Universal Declaration of Human Rights<sup>1</sup> says itself that, "All Human Beings are born free and equal in dignity and rights". For this purpose the LGBT community or the Gay community was made and rights were set up order to protect the dignity and rights of the lesbian/gay/bisexual/transgender people. The transgender have been further classified as

- 1. MtF transgender Male by birth and gender identity as female
- 2. FtM transgender Female at birth and gender identity as male
- 3. Agender Neither male nor female
- 4. Bigender Both male and female identity
- 5. Pangender May be more male today and female tomorrow or may be in between
- 6. Genderfluid May be more female today and male tomorrow or may be in between and the list goes on.

## India vs. Other countries

Not only India comprises of transgender people, but other continental countries too have transgender people. Some countries had provided them with laws and some are on verge of acceptance of laws for the rights of transgender people. The places where law has not been vet accepted or implemented doesn't give authority or right to people to ignore these people, in fact a way should be made out of all the controversies going around in regards of transgender people. According to a report by Jack Harrison, Task Force Policy Analyst, "Argentina becomes the world's most transgender friendly country."<sup>2</sup> Including Argentina, there are 7 other countries which gave transgender people there fundamental rights. Those countries are Nepal, India, Pakistan, Bangladesh, Germany, New Zealand and Australia. Nepal became the world's 1<sup>st</sup> country which mentions the third gender as an option in the census form in 2011.

# **Rights of Transgender under Indian Constitution**

Our Preamble says about the constitutional justice in status of social, economic and political equality.

- ✓ Article 14 says about right to equality.
- ✓ Article 15 says about the prohibition of discrimination on the grounds of religion, race, caste, and sex or birth place.
- ✓ Article 21 speaks about the right to personal dignity and privacy to all citizens.
- ✓ Article 23 speaks about prohibiting trafficking in human beings

Also, the petition<sup>3</sup> filed by Transgender Lakshmi Narayan Tripathi with the help of NLSA, SC judges A.K. Sikri and K.S. Panicker Radhakrishnan gave a historical decision and it was held that transgender are third independent gender of society and have equal rights in property, in society and also matrimonial rights just like every other males and females of

society, and constitutional rights will be equally applicable on them like other two genders of the society.

But still the sexual preference of transgender is still pending and is being discussed. After the SC decision, transgender got a place in society and now have an equal status like male and female status. They got the right to:

- ✓ Marriage
- ✓ Divorce
- $\checkmark$  Adopt a child
- ✓ Vote

## Problems faced by transgender people

- 1. Discrimination in their own family.
- 2. Discrimination at work places.
- 3. Not getting proper educational facilities.
- 4. Not getting proper medical and sanitation facilities.
- 5. Physical and verbal abuse.
- 6. Forced prostitution.
- 7. Threat to life.
- 8. Poverty
- 9. Harassment and stigma
- 10. No proper healthcare
- 11. No legal identification documents

They are transgender because they do not possess masculine and feminine features completely i.e. they are hetero-mixture. We live in same society still transgender are the ones who have a struggling life and are ignored and harassed by the society. They are not allowed to approach public toilets and facilities. In their own families, the son is not accepted and is being scolded or beaten up for dressing like a girl or lady and are also disowned by parents.

Even from the cops they face physical or oral violence, extortion, sex abuse and sometimes false allegations also. Due to absence of protections from on duty authorities the Hijras are an easy target for money and sexual things. In recent survey, "Transgender in Kerala continues to face discrimination as weak grip".<sup>4</sup>

In a report of April 2011, it was estimated by the Williams Institute that about 0.3% were identified as American transgender of 2 states, California and Massachusetts, and the same was estimated in June 2016 report, that the percent increased to 0.6%. Also, in 2011, the same was found that 8.2% of Americans had engaged to same sex sexual behavior and 11% got attracted to same sex person.<sup>5</sup>

### Help needed to upgrade status of transgender

- ✓ Every person including Hijras, should have equal right to express their sexual identity.
- ✓ The process of untouchability among the Hijras should be taken in consideration and should be abolished in society and there should be legal protection against this discrimination.

- Right to get a ration card ; or
- Right to make a will ; or
- Right to inherit property ; and
- Right to adopt a child

must be allotted to them regardless of any improvements in their appearances.

★ To prevent them from being raped at Brothels and in police custody, protection and safety should be provided. Hijras must not be sent in female cells just to protect them from being harassed, abuse or rape.

A compulsory subject on sex-education should be inserted as a part of academic curriculum in order to make children aware of sexual information, orientation and sexual behavior.
